NEW TURNOVER RECORD at 24,3 MILLION €
FURTHER INCREASE IN PROFIT MARGIN

- **Income: 24.3 million €** , +2% compared to 23.8 million € of the financial year 2017
- **EBITDA: 4.1 million €** , compared to 3.9 million € of the financial year 2017, with a **16.7% incidence on income**
- **Net profit before taxes: 3.0 million €** , compared to 2.9 million € of the financial year 2017, with a **12.2% incidence on income**

Genoa, April 2nd, 2019 – The Shareholders' Meeting of OMP Racing S.p.A., a company controlled by SAYE S.p.A., convened today, has approved the financial statements related to the financial year 2018¹.

During the financial year OMP has earned **Income** equal to **24.3 million €**, in comparison with 23.8 million € recorded in 2017. The overall growth, of 2%, has been noticed particularly in Europe, Oceania, the Americas and Africa.

Ebitda has attested at 4.1 million € equal to 16.7% of sales Income, growing in comparison with 2017 when it attested at 3.9 million € (+ 16.2% of Income), thanks to the contribution of products innovation, to new multi-year agreements with automotive companies and Teams and to the greater and greater strength of OMP brand at a global level.

OMP Net Profit before taxes is equal to 3.0 million, with an increase of +5.2% if compared with 2017 and represents 12.2% of Income. The Net Profit after taxes is equal to 2.2 million €, in comparison with 2.0 in 2017.

Net Financial Debt at December 31st, 2018 is equal to 5.3 million €, in decrease in comparison with 5.7 million €, in 2017.
